Shall Senate Bill 1641, enacted at the 1967 session of
the Legislature of Florida which became a Law August 4,
1967, entitled:


"An Act creating and incorporating a special Tax
District in Monroe County, to be known as "The
Lower Florida Keys Hospital District"; fixing and
prescribing boundaries of the District; naming the
first Board of Commissioners and providing for the
appointment by the Governor of successor Boards of
Commissioners and for filling any vacancies on said
Board; providing for the governing and administration
of any hospital or hospitals established within the
District; providing and defining the powers and
purposes of the District and Board of Commissioners
thereof; authorizing the Board to establish, contract
for, lease, operate and maintain any hospital
established in the District; providing for sealed
bids for purchases of supplies, equipment and con-
tracts for construction or repairs in excess of
two thousand dollars (\$2,000.00); authorizing and
providing for the issuance and sale of District
Bonds; authorizing the Board to borrow money;
authorizing and providing for levy and collection of
ad valorem taxes on all property in the District for
payment of bonds and notes and interest thereon, and

for the repair, maintenance and operation of a hospital or hospitals; authorizing the establishment of hospital medical staffs, nursing school and a nursing home; providing a referendum of the Freeholders within said Hospital Tax District."
